

PERMIT PROCEDURE FOR INTERIOR DRAIN SYSTEMS AND SUMP PUMPS

Before applying for a permit please read and submit all the following items for review:

□ **Residential building permit application** (filled out in its entirety)

□ **Two (2) copies of a current to-scale property survey** — showing property lines, yard offset dimensions, rights-of-way, and all applicable accessory structures. Survey shall have the surveyor's name and seal. A typical to-scale property survey is on 8½"x14" (legal size) paper. *Photos or distorted surveys will not be accepted*.

The location of the water discharge from the sump pump shall be accurately shown on the survey (can be sketched by hand) showing compliance with Chapter XV, Section §303 Uncontrolled Water Discharges (sump pump ordinance) of Mt Lebanon ordinances. The water cannot be discharged to a public way (ie: street or sidewalk) or directed at, or negatively affect a neighboring property and must be a minimum 10 feet from any property line.

If available, it is preferred the sump pump discharge is tied into a municipal storm sewer system. If a municipal storm sewer system is not available, the water discharge shall be controlled using best management practices as outlined in Chapter XIII, Part 3 Stormwater Management Ordinance, Appendix B Small Project Stormwater Management.

□ **Two (2) copies of the proposed work/construction details** – a complete description and/or drawings of the proposed work showing compliance with the Statewide Building Code. A minimum 3½" of concrete is required to be placed over the pipe or drain when the concrete is repaired.
