### Vibrant Uptown Charter

### Vibrant Uptown Charter – Project Tenants

# Accessibility

• Strive to go beyond standard ADA requirements to create an Uptown District that is truly accessible to all members of our community;

### Connectivity

• Strive to develop and strengthen the linkages between pedestrians, mass transit, automobiles and our commercial stakeholders. Connectivity will also include technological linkages where appropriate;

# Sustainability

• Strive to create an Uptown District that values sustainable practices in design, materials and environmental considerations;

# Inclusivity

• Strive to welcome all voices throughout the duration of the project.

#### Innovation

• Strive to employ innovative design, planning and implementation principles.
